### Summary

Performs a variety of routine and complex detective related law enforcement activities and work. Assists on various teams and task forces as designated by the Captain and performs investigations on criminal, civil, and traffic offenses.

### Essential Functions

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

1. Works with a multi-jurisdictional narcotics task force to assist with narcotic investigations which may include surveillance, developing and supervising informants, developing raid plans for the execution of search warrants, overseeing and supervising lab cleanup, evidence processing, completion and filing of State Police paperwork, and assists other agencies with their investigations.
2. Investigates and renders assistance at the scene of vehicular accidents. Summons ambulances and other law enforcement vehicles and personnel, takes measurements, draws diagrams of the scene, interviews suspects, witnesses, and drivers, and preserves evidence.
3. Conducts follow-up investigations of crimes to develop leads and tips, searches scenes of crimes for clues, analyzes and evaluates evidence and arrests offenders, and prepares cases for giving testimony and testifying in court proceedings.
4. Initiates and conducts follow up on investigations for felony and misdemeanor criminal investigations such as criminal sexual conduct, child abuse, missing persons, home invasions, financial crimes, murder, abuse, and stolen vehicles.
5. Review case reports to determine a plan of action and the coordination of other agencies or departments, contact victims, witnesses, and suspects by phone or in person, record criminal reports and written paperwork for the Prosecutor's Office, implementing search warrants and arresting individuals, complete booking intake paperwork, and logging evidence.

6. Respond to critical incidents in which hostage negotiations are needed. These incidents can include suicidal subjects, barricaded individuals and a direct assistance for SWAT team on all call out incidents.
7. Collect evidence from various types of incidents by determining which items to collect, preserve the item for collection, take photographs, collect DNA, collect latent prints through dusting, search the area which may contain evidence, transport evidence, read and record lab results, and record reports.
